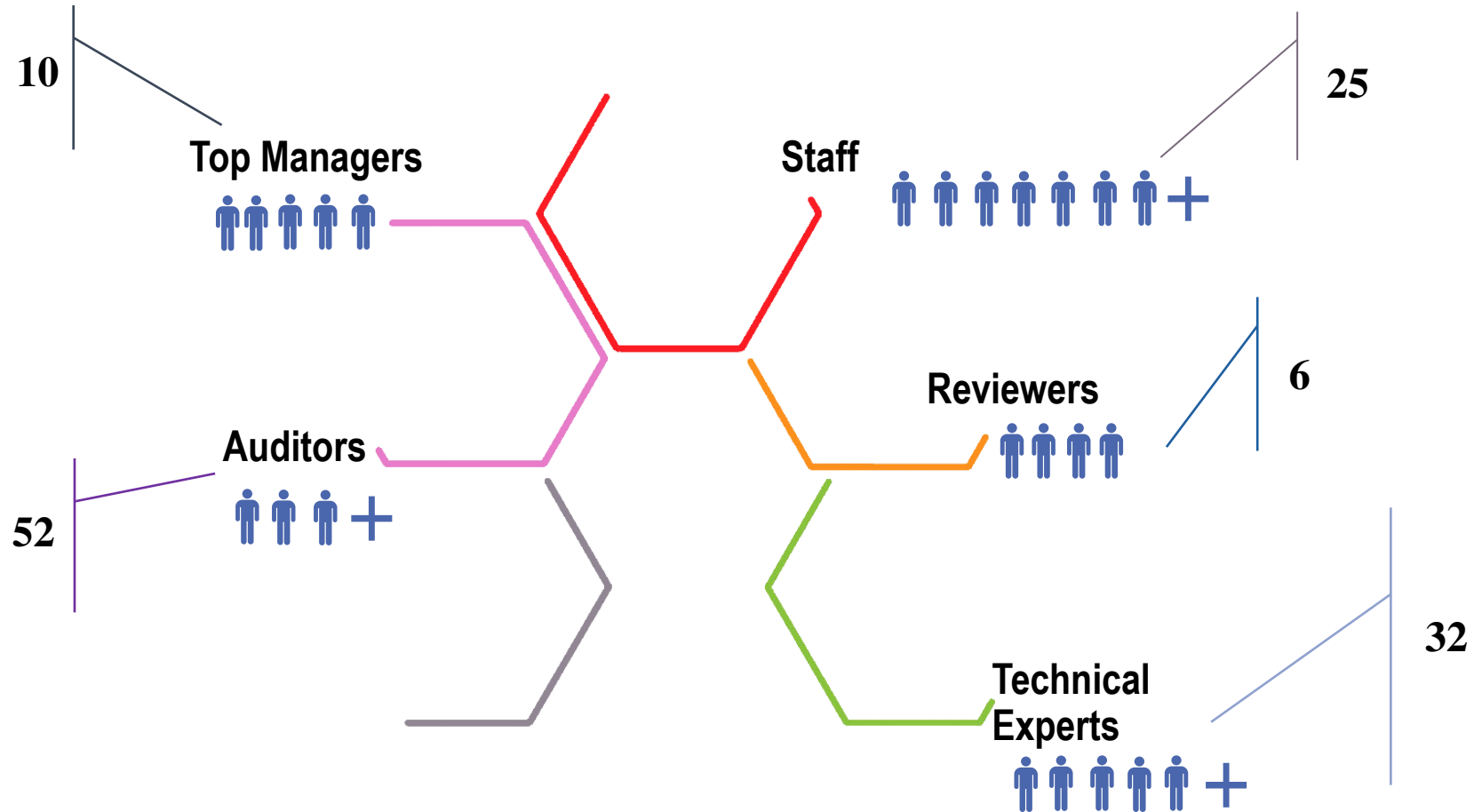

EN 10080 and BS 4449

The European standard EN 10080 is a crucial guideline established by the European Union (EU) that outlines the general requirements for ribbed, weldable reinforcing steel used in concrete structures. This standard applies to steel provided in various forms, including bars, coils (rods, wires), and decoiled products. It offers comprehensive details on definitions, testing methods, conformity assessments, and the identification of both the manufacturer and the technical class.

The British Standard BS 4449 complements EN 10080 by specifying the requirements for ribbed, weldable reinforcing steel used in concrete structures. Similar to EN 10080, BS 4449 applies to steel in bars, coils, and decoiled forms and categorizes steel into grades B500A, B500B, and B500C, each with 500 MPa yield strength but differing ductility levels. ATC INTL is a leading certification body offering comprehensive services for organizations seeking certification under EN 10080 and BS 4449.
